This will be carried out by assessing the three case studies each bidder puts forward. Each case study will be marked out of 8 and bidders not obtaining at least 12 marks in total will be failed unless they can provide supporting information of why three case studies could not be submitted, for example, the consortium team is a new entrant into the UK market.
