of Specialist Temporary Agency Early Years Practitioners'.

The annual procurement spend is in the region of up to £540,000 but there is no guarantee

that this level of spend during this new framework will be achieved.

The agency margin will be fixed for the duration of the contract, although statutory costs and

temporary worker hourly rates may be amended in line with government legislation.

The Framework Agreement will last for a period of up to but not exceeding four (4) years (unless terminated under the Framework Agreement provisions).

The procurement will be structured as follows:

- Specialist Temporary Agency Early Years Practitioners.

The Framework Agreement will be awarded to a maximum of five (5) agencies and the

allocation of shifts on the following basis:

- The first ranked agency, in terms of MEAT will be provided with shift requirements for a two week period for 'Band 300 Nursery Practitioner requirements' and will have a period of one week to confirm whether or not that they can fulfil the request
- Those shifts that have not been fulfilled will then be communicated to the other agencies on the framework
- Based on the first response received, those agencies that confirm that they can fulfil the request will be awarded the assignment(s).

- Band 300 Nursery Practitioner Level 3 - Qualified
