- Applying patient-focused outcomes in accordance with the Mental Health (Wales) Measure 2010.
- Improving community safety and reduction of risk, ensuring absolute compliance with legal requirements applicable to patients/patient rights
- Establishing standard contract terms/conditions and a transparent pricing framework
