The preferred consultant will act as the Principal designer and oversee the project through all RIBA Stages until completion on site and handover.

These deliverables need to be completed to no later than the 1st March 2025.

They should also be utilised to seek support from private home owners to enable the works to be successfully delivered, prior to the planning application being submitted (if required).

Produce all necessary planning/building control applications and associated support documentation - Secure all necessary statutory consents to enable the works to proceed.

Produce RIBA 4 designs and produce Site and Works information to enable a contractor to be procured (NEC Option A or B). This should include final scheme costings, programme and a quantified risk register - Produce detailed designs for the proposed site improvements. These should be utilised to inform the scheme cost estimate, programme and risk register. They should also form the basis for the works information and associated site information which will form part of a NEC Construction Contract (either Option A or B).

Provide the Council with Project supervision during the works - Provide the Council with on site project supervision throughout the works contract.

Take on the role of PD throughout all RIBA Stages - The preferred consultant will take on the role of PD throughout the commission.

Proactively address defects on site - The preferred consultant will support the Council in addressing all site defects both during and after the construction works are completed.
