the lawful direct award of a contract.

Additionally and in line with the practices of: Fairness; Openness and Transparency; the publication of this VEAT Notice has been

balanced against the risk that publication of this VEAT Notice may, in fact, increase awareness of the proposed direct award and increase

the risk of challenge.

A VEAT was the best legal procurement route to take because the disruption as a result of installing a new system would be significant and would have wide reaching consequences impacting: Staff; Patients and Services.
