Parliament, Scottish government, Scottish Parliament, Northern Ireland Assembly and Northern Ireland Executive. The National Archives uses external contractors to help deliver the Lawmaker service including through maintaining infrastructure and software, providing user support, ensuring security, developing new features and extending the service to new use cases.

#### Legislation services

The National Archives is responsible for providing the <u>legislation.gov.uk</u> Platform which:

makes both enacted and revised legislation available on the web for the public to access and use, and

We use external contractors to manage the maintenance and development of this Platform, which includes the <a href="legislation.gov.uk">legislation.gov.uk</a> website, a research website, the <a href="legislation.gov.uk">legislation.gov.uk</a> editorial system, and the <a href="legislation.gov.uk">legislation.gov.uk</a> publishing system. We are looking for suppliers with the technical skills and experience to maintain and continuously develop the <a href="legislation.gov.uk">legislation.gov.uk</a> Platform to ensure it is accessible, robust and performant.

Statutory responsibilities for the official publication of all UK legislation are managed through a separate publishing concessionary contract.
