Currently the nature of the service mean there are no realistic alternative providers, due to the provider operates an integrated workforce model to deliver their portfolio of services. It would not be viable to manage TUPE arrangements to an alternative provider to ensure continuity of service provision. Current provision is from within the providers existing estates in hospital setting as well delivering services from Health Centres across Northamptonshire.
