II.2.4) Description of the procurement

The GSCIP project is led by DBT and currently supported by six government organisations. It combines HMG, private sector and open-source data to build detailed global supply chain maps at both commodity and company level using a knowledge graph, and graph data analysis and visualisation tools.

The first phase of supplier engagement provided valuable insights into market capability to deliver a 'No Code' web application XL graph-style database. This enabled us to develop a comprehensive specification of requirements with the intention of delivering not only current needs, but also giving consideration to potential future innovations.
