The works will be on an as and when required basis and will include but not be limited to the full and partial replacement of wet, gas based domestic central heating systems and electric fires / surrounds to South Tyneside Councils housing stock.

South Tyneside Council Housing Services, Property Services and Asset Management "in house" labour team, deliver heating installations and associated works to properties within South Tyneside.

Where South Tyneside Council cannot deliver the requirements of the programme, we are looking to engage the services of a contractor to deliver the shortfall in heating installations and associated works.

the identified works and the number 2 ranked tenderer will be held in reserve.
