Hywel Dda University Health Board (HDUHB) is one of seven health boards in Wales and is responsible for improving the health and wellbeing of around 385,600 people living in HDUHB and for enabling the provision of high quality, effective healthcare services. With the very rural nature of HDUHB, the majority of local services are provided locally, through General Practitioners (GP's) and other primary care services, community hospitals and community services.

HDUHB is seeking bids from forward thinking and innovative partnerships wishing to provide general medical services in the Neyland & Johnstown area for the General Medical Services (GMS) or Alternative Provider of Medical Services (APMS) contract of Neyland and Johnston Surgery

The EMIS practice is currently managed by Hywel Dda University Health Board and provides services to approximately 5,900 patients from two sites, with medical centres located in the small marina town of Neyland and the quiet mile-long town of Johnston in Pembrokeshire. One of five practices in the South Pembrokeshire Cluster, the community is served locally by Withybush General Hospital, Haverfordwest (5 miles) and Glangwilli General Hospital, Carmarthen (35.4 miles).

The aim is to return the practice to independent contractor status from 1st April 2024.
