The modification is to advise of the extension and variation of the Council's contract with Nottinghamshire Healthcare NHS Foundation Trust (NHFT) for delivery of the Nottinghamshire Healthy Families Programme (HFP) .

#### VII.2.2) Reasons for modification

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and

explanation of the unforeseen nature of these circumstances:

This is an urgent modification notice under the NHS Provider Selection Regime (PSR) regulations. 14(2)a, b and c:

- (a) an award or modification must be made urgently,
- (b) the reason for the urgency was not foreseeable by and not attributable to the relevant authority, and
- (c)delaying the award of the contract or modification to satisfy the requirements of regulations 6 to 13 would be likely to pose a risk to patient or public safety.

The modification must be made urgently due to no contract extension periods available on the current contract and therefore outside of the scope of the regulations and is as a result of matters that have arisen, which were unforeseeable and outside the Council's control in response to the 'rapid review' of mental healthcare provision at NHFT by the Care Quality Commission (CQC). The extension will give the Council time to take into account the Care Quality Commission (and any other regulatory bodies) actions and recommendations and to consider the best way of delivering the Nottinghamshire HFP in the future.
