- Any bloods that are required on attendance at these secondary fertility clinics and will be taken in the WHH outpatient phlebotomy service.
- If an ultrasound or hycosy is required the fertility consultant will order via WHH EPR system. The ultrasound or hycosy will be performed by WHH radiography team.
