The South Eastern Health and Social Care Trust requires the purchase of the EMIS Web system, currently in situ. This is required to maintain service requirements whilst a regional solution is established. EMIS Web has exclusive rights for this technology and no other supplier is capable of providing an alternative system compatible with current Trust requirements at this time.
