Any carriers of computer and Information and Communication Technology (ICT) equipment will require a Hazardous Waste Carriers Licence from the Environment Agency and copies of all carriers' licences must be provided as part of the tender submission.

All treatment of equipment must be carried out at a registered Authorised Treatment Facility (AATF) and details of these facilities must be provided.
