35.00%

Key Criteria 3: Quality and Innovation: 15.00%

Key Criteria 4: Social Value: 10.00%

Key Criteria 5: Value: 20.00%

Only bids which Pass all Basic Selection Criteria Questions shall proceed to be evaluated for the Key Criteria Questions. Lots will be awarded to the Provider that passes the Basic Selection Criteria and achieves the highest Key Criteria score of the respective Lot with only bids which Pass all the requirements to be scored on Key Criteria.
