The WY ICB is re-opening this window for new entrants to join the Any Qualified Provider (AQP) list. We are also requesting that current providers re-apply to ensure that they still comply with the requirements of the qualification criteria.

The principle aim of the service is to provide a local consultant-led community ENT services for the diagnosis, management, and treatment of ENT problems, which

complement and work in partnership with existing primary, community, and secondary care ENT.

In addition, by providing a fully integrated Adult Hearing Loss service, the providers will support adults experiencing difficulties with their hearing and communication who might benefit from hearing assessment and care, including the option of trying hearing aids to reduce these difficulties.
