The aim of the Service will be to provide a non-clinical weight management offer to enable individuals to lose weight safely within the context of a comprehensive approach to prevent and treat obesity. The multi-component group support service will be based on the guidelines and quality standards of the National Institute for Health and Care Excellence (NICE).
