The DE&S Future Capability Group (FCG), in conjunction with the Royal Navy, are looking to demonstrate a modular (20ft ISO container) medium size loitering munition automated launch and storage POD.

The project end state is seeking to establish the viability of, and to provide, a deployable integrated launch module for loitering munitions through a successful maritime, land and littoral concept demonstration.

Industry advice is sought on the cost and timeframes (through VROM submissions) of key phases of activity to develop and demonstrate an initial concept system culminating in a number of live fire events.
