Firefighters are classed as 'licensed workers' under the Control of Asbestos Regulations 2012 (CAR 12). This means they are required, by law, to undergo medical surveillance with a Health and Safety Executive (HSE) appointed doctor, every three years.

This will require the delivery of circa 6000 operational employees on a rolling three-year programme (i.e. 2000 medicals per year carrying out seven medicals per day). As such, the Service intends to implement a Framework Agreement involving all HSE Registered Doctors who provide a compliant response to the Service's Statement of Requirements.
