Extension of the framework until the replacement NHSScotland Framework Agreement is in place. This modification is to meet continued demand by NHSScotland Health Boards, while the strategy conclusion and procurement of the new framework is underway. The extension ensures continuation of supply under Regulations 72(1)(b) -significant inconvenience and substantial duplication of costs..

#### VII.2.2) Reasons for modification

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

A review of the requirements for the successor framework identified that further technical Consultancy services in addition to the Supervisor role are likely to be required. This includes the proposed Compliance Plan Manager function. Further work is required to develop the NHSScotland strategy for a technical services framework which will include NEC Supervisor services. NHS National Services Scotland deemed that putting in place a short duration framework until such time a fit for purpose "technical services" framework constitutes significant inconvenience and substantial duplication of costs in line with Regulation 72(1)(b).
