It is likely that NWS will be running a below threshold procurement, reserving the procurement (in line with PPN 11/20) for suppliers located in the Cumbria area. This means that suppliers will need to be based in Cumbria or have substantive business operations in Cumbria (rather than by location of corporate ownership)
