Essex County Council (the Council) has a commitment in Everyone's Essex 2021 to 2025 to accelerate the county's transition to renewable and sustainable energy. As part of this, the Council has set a target for its core estate to reach net zero by 2030. Electricity consumption is projected to decrease over the coming years through investment in energy efficiency and estate rationalisation, but the Council also has a commitment, through its renewable electricity strategy, to access 100% of its energy requirement from renewable sources and to maximise opportunities for both onsite and offsite renewable electricity generation.
