The target is for 500 students to go through the Access to Medicine programme in 2023/2024 and 2024/25, with locations including hard to reach areas such as Sandwell, Kettering, Nottingham, Liverpool and Doncaster (the 20% of worst performing local authorities identified by the Social Mobility Commission as social mobility cold spots) Additional targets

- Gender applications target is to see no less than 35% male students in the cohort
