- Extended Reality or Immersive Technologies (XR) is an umbrella term that encompasses virtual reality (VR), augmented reality (AR) and mixed reality (MR).

XR enables a digital layer on top of the real world. This can range from small changes to the physical environment, such as visual overlays, to large changes, such as entire simulated worlds.

The NICE Evidence Standards Framework for Digital Health Technologies (DHT) shows how the technologies (AI and XR) can expand through all the spectrum of risk related to intended use. This means that they can be used for treating and diagnosing medical conditions, or guiding care choices (Tier C), for helping people and patients to manage their own health and wellness (Tier B), or they can intend to save costs or release staff time, with no direct patient, health or care outcomes (Tier A). We will align to NICE Classification of technologies.

NHS SBS intends to add additional categories over time and all DPS suppliers and those who wish to join the DPS, will be invited to express an interest in any additional category.
