At the end of the procurement process, the Lead Provider (Central and North West NHS Foundation Trust) was awarded two separate contracts to provide both Sexual Health Services and HIV Services to residents.

The Sexual Health Services contract is held between Surrey County Council and the winning provider.

The HIV Services contract is held between NHS England & NHS Improvement, and the winning provider.

Sexual Health services are statutory services which Local Authorities are required to provide as part of their Public Health responsibilities.

This was a joint re-tender with NHS England and NHS Improvement South East, and Surrey County

Council for Sexual Health and HIV services. The contract commenced from 1st October 2022, with a contract length of 60 months and an option to extend for a further period of 24 months.

The two services are commissioned from a single provider and will be delivered via separate contracts, with the County Council holding a contract for Sexual Health Services and NHSE/I responsible for the HIV services.
