The provider will work in collaboration with the Health & Social Care Partnership and other private organisations to help us deliver our strategic plan and provide high-quality, person-centred care based on enablement and positive outcomes.

The maximum hourly rate payable is 21.41GBP

Additional capacity is required from as early as possible in January 2023, and providers are asked to confirm the date from which hours can be delivered.
