The City Lions programme focuses on developing young people's cultural capital, with all projects maintaining a creative emphasis.

The provider must demonstrate a comprehensive understanding of the numerous barriers faced by young people and possess a strong commitment to improving access to the creative sector, building transferable skills, and broadening young people's horizons. Experience in forging strong and sustainable relationships with young people, schools, and cultural organisations is essential.

Subcontracting any part of the contract is prohibited unless prior written approval is sought.
