An extension of the current offer (for adults) to include young people aged 16-25 with Education, Health and Care Plans is being considered.

The services enable people to connect with the local community in a way that optimises independence, choice and control.

Support with Everyday Living comprises the following models of care:

- Supported Internships (young people aged 18+ with Education, Health and Care Plans) and Supported Internships (young people aged 18+ without EHCPs but with additional needs)
- Unpaid Vocational Activity
- Community-based Outreach
- Day Services
- Non-residential Short Breaks
- Independent Travel Training
