#### II.2.4) Description of the procurement at the time of conclusion of the contract:

The Central Vale Cluster comprises of 6 GP Practices and serves a total population of 64,175. The cluster area is a mixed urban and rural demographic, and includes some pockets of significant deprivation. The population is expanding with extensive new house building.

The cluster is seeking to continue to develop, deliver and test a 'single point of coordination and access' to local, community delivered wellbeing and support service for those individuals identified by the GP Practices with the highest level of wellbeing needs.

The Central Vale Cluster is looking to continue work with Mind in the Vale who can provide practices within the area, with a small team of dedicated staff who will be able to accept and manage referrals from the 6 practices as part of a 'single point of coordination

and access' model. These referrals will be for patients who require onward referral onto existing, locally provided community services to meet their socio-economic and wellbeing needs as opposed to primary health needs.
