The purpose of this Transparency Notice is to announce the Animal Plant and Plant Health Agency's (APHA) intention to enter into a contract for a Premium Plus Service Plan with Hamilton Sales & Service UK LTD for 3 years with options to extend by a further period of up to 2 years (i.e. 3+1+1). It will provide Preventative and Corrective Maintenance services for the equipment, which can only be provided by the Original Equipment Manufacturer (OEM).
