Representations by providers must be made to the relevant authority by 15th November 2024. This contract has not yet formally been awarded; this notice serves as an intention to award a contract under the competitive process of the PSR.

The decision to award the contract was made by the Procurement and Patient Choice Panel within the ICB's agreed governance process and delegated limits. There were no declared or potential conflicts of interest of individuals making the decision. The relative importance of the key criteria is stated in II.2.5 above. Providers recommended for award for this procurement were required to have an aggregate score of at least 60% to be awarded a contract.
