NHS Buckinghamshire, Oxfordshire and Berkshire West (BOB) Integrated Care Board (ICB) was looking to continue Unscheduled Dental Care (UDC) with the current provider in Thatcham, West Berkshire.

The contract will be for a term of 2 years. Services are due to commence from 1st April 2026.

The maximum total contract value is £135,486.00.

There were no declared conflicts or potential conflicts of interest of individuals making the decision.

Award decisions have been recommended by the BOB ICB Pharmacy, Optometry and Dental Oversight Group, which is chaired by the Director of Primary Care who reports to the board-level Medical Director.
