The Key Criteria were weighted as follows;

- Quality & Innovation – 18.00%
- Value – 0.00% (This was scored as Pass/Fail)
- Integration, Collaboration and Service Sustainability – 63.00%
- Improving Access, Reducing Health Inequalities and Facilitating Choice – 7.00%
- Social Value – 12.00%

The preferred provider scored a pass on all of the pass / fail questions within the Basic Selection Criteria and for the Key Criteria Section 2: Value questions. The preferred provider also scored the highest overall for the Key Criteria Questions (Sections 1,3, 4, and 5) against the published scoring criteria (set out at paragraph 27.3.2 of the Competitive Process – Overview and Instructions)
