The opportunity is for a research company to carry out a robust evaluation, including measures of impact, of recipients of grants from the South Yorkshire Violence Reduction Unit (SYVRU) Violence Reduction Fund. The evaluation will need to achieve the highest methodology rigour possible whilst being responsive to the individual needs of the recipients evaluated.

Extension 4. 01/10/2027 to 31/03/2028, to begin grant round 3 until the end of SYVRU funding.

Extension 5. 01/04/2028 to 30/09/2028, to conclude grant round 3 provided continued funding for SYRVRU.
