The London Borough of Enfield ('the Council') is notifying the supply market of a forthcoming contract opportunity with an intention to procure the provision of a long-term domestic abuse refuge and independent domestic violence advocacy (IDVA) Services (Services/the Services) in the borough.

This is a pre-procurement notification to alert the supply market of a future contract opportunity. The service is to provide temporary accommodation and support for women aged 16 years and above including their children (where applicable) who are subjected to domestic abuses.

- 1) providing accommodation and support in a purpose-built 21-bed refuge accommodation (Refuge);
- 2) providing independent domestic violence advocacy (IDVA) support for survivors of domestic abuse targeting high-risk survivors of domestic and sexual violence and children at risk of harm with the primary object of securing their safety.
