The authority confirms the provider delivers the contract to a consistently high standard and no material changes have been made in the renewed contracting arrangement.

The consistently strong performance and system alignment supports continued commissioning of this service via Direct Award C.

Against the Provider Selection Regime (PSR) Key Criteria, the provider has demonstrated expertise and is anticipated to continue doing so. Evidence of current service delivery against the PSR Key Criteria and the breakdown of Key Criteria weighting in relation to this service for the purposes of awarding a further contract under Direct Award C is detailed below:

Quality and Innovation (35%)

- The provider has delivered safe and effective care, including early diagnosis, management of gynaecological symptoms, and minor procedures, in a primary care setting.
- The provider has implemented robust clinical governance, continuous audit, and pathway alignment to ensure patient safety and clinical effectiveness.
- The provider's ability to innovate within the constraints of general practice - such as by providing flexible appointment models and digital access for example - demonstrates their responsiveness to patient and system needs.

Value (20%)

- The practice has delivered excellent value for the local system by reducing reliance on acute outpatient services, improving referral appropriateness, and ensuring patients are seen closer to home.
