Accuracy International Ltd is the manufacturer and sole distributor of spares to support the components required to support the AS50 Sniper Rifle Weapon Platform. They own the rights to the technical specifications required to undertake the manufacture, testing and supply and they do not share this knowledge/expertise with any third party.
