Leidos, working with the MOD, will transform the way these services are delivered to ensure requirements continue to be met whilst providing best value for money for the department. The organisation delivering these services is known as Team Leidos. Team Leidos would like to make interested suppliers aware that it has awarded tenders for its supply and delivery of Leather Gloves.

The defense clothing team, which forms part of Leidos Supply Ltd has awarded the tender for the requirement of the supply of Leather Gloves on behalf of the UK MOD, consisting of 1 Lot. The estimated value is £3.2m over the 4 year period - 3 years + 1 option year.
