Support offered will be in accordance with the purpose of Housing Support Grant set out in Welsh Government's Housing Support Grant Practice Guidance, to prevent homelessness and support people to have the capability, independence, skills and confidence to access and/or maintain a stable and suitable home.

The service will enable people where a refuge or hostels may not be appropriate, to access accommodation related advice and support to remain safely in their homes and reduce the risk of homelessness. We have decided not to specify how many individuals the service will support at any one time across Wrexham County Borough but will leave this up to the bidder to determine.
