The Schools Water Strategy (SWS) is an invest to save service aimed at reducing the risk of flooding in schools.

One of the workstream elements within the SWS is the delivery of Property Flood Resilience (PFR) measures within schools which are at risk of flooding. The team works with schools who either have the highest forecasted flood risk or have flooded previously to protect the school building and pupils' education days.
