Post CSE Support Services are services intended to help victims and survivors of CSE and their immediate families overcome the impact of their trauma experienced. Other intended outcomes from the services are:

- Build resilience and develop coping strategies for everyday

life

- Improve their self-esteem and self-confidence

- Improve their mental health and wellbeing
- Be supported in fulfilling their maximum potential
- Reduce the risk of harm.

The contract is intended to commence on the 1st January 2026 for a 3-year period with a fix and firm contract value.

The Post CSE Support Services are contracted in three separate lots with separate contract values.
