Following a sustained period of high demand, post-pandemic Suffolk County Council (SCC) entered into a Pilot with an existing Provider to deliver a Bridging Service in Suffolk to deliver care to Customers on the Outstanding Home Care Support List (Waiting List). The Pilot solution allowed staff to be deployed into Suffolk, thus not creating further pressure on an already fragile local staffing resource.
