Data Networks Upgrade



### **VII.2.2) Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

There is a need to upgrade the data networks at 4 of the Business Centres (Moorgate Crofts, Fusion@Magna, Matrix@Dinnington and Century Business Centre) to expand existing WIFI provision to cover the full building to meet the modern needs of occupant businesses.

Procuring from a different supplier would create complications of who is responsible for maintenance when issues arise, creating extra costs because of duplication of work, and

potential delays in resolving problems that would impact client service levels. Also, extra costs would be incurred at commissioning as the new supplier would have to undertake additional work including device firmware and acceptance testing with the incumbent system, a duplication of work.
