For Avian Flu and CH Outbreak:- Upon signature of a returned contract and PGDs the Pharmacy will receive an annual payment of £400 to agree to maintain readiness to provide the service.

The retainer fee will also cover the readiness for the supply of antivirals via PSD in the event of an outbreak of Influenza in care homes.
