For clarity, the estimated value of the contract below was based on a maximum potential contract duration of 5 years, in which

the total value of services required may range up to £500,000 per annum (giving a potential range of between

£500,000 and £1,500,000 for the initial 3 years of the contract).

This option to extend would only be considered upon satisfactory performance of the successful provider and the requisite funding being made available to Visit Belfast. Projects within the contract would be agreed individually and Visit Belfast was under no obligation to award any services required exclusively to the successful provider or ensure any number, value or scale of projects during the contract.
