This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023 - Direct Award Process C. For the avoidance of doubt, the provisions of the Procurement Act 2023 do not apply to this award. The publication of this notice marks the start of the standstill period. Representations by providers must be made by midnight 27/06/2025. This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR. They provide an integrated service within the Trust's and community care system enhancing patient choice and accessibility, while also supporting employment in the local community. This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. This contract has now been formally awarded using the Direct Award C process. The contract was awarded on 30th June 2025. The contract is for the period from 01/07/2025 to 31/03/2026 with an option to extend for a further 2 periods of 3 months each. The estimated contract value is £150,000 for the initial 9 month term and up to £200,000 if the full extension option is exercised.
