There is currently no Health Check Service provided in Sheffield since the previous contract expired on 30th April 2021. Due to the Covid-19 pandemic a decision was made to pause the service due to ongoing service pressures and uncertainty. As part of the recovery programme Sheffield City Council is now seeking to commission a single service provider to deliver the NHS Health Check programme for the whole City that may itself sub-contract with another provider(s). The contract amount is £185,000 per year for a period of five years. The contract will commence on 1st December 2023
