A 12 month agreement was sought to allow sufficient time for NWSSP Procurement Services to undertake a competitive procurement however, due to various factors it has not been possible to complete this therefore an additional 6 months plus 6 months extension period has been sought.

The Health Board cannot find a Public Sector Framework with which to engage with Abbott Laboratories Ltd at this time and therefore, there is no opportunity to make a compliant direct award.
