This will involve implementing a locally agreed, co-designed model to address the reform areas in family help, child protection, family networks and establishing education as a fourth statutory partner. The local model is to be informed and shaped by the DfE minimum expectations outlined in the FFCP design specification. To support the implementation of reforms, Wolverhampton has been allocated £4.4 million from May 2023 to March 31st 2025.
