Histocompatibility & Immunogenetics (H&I) is a strategic business function of NHSBT, that provides a portfolio of testing, advice and support in transplantation, platelet refractoriness and transfusion.

Services are supplied through a national network of seven laboratories across England. We would like to work with future suppliers of choice to perform DNA extraction in an efficient, timely and cost-effective manner to meet the demands and expectations of our customers and the patients we serve.

Prior to commencing a formal procurement process and to help inform our strategy, NHSBT is seeking to engage with suppliers of commercially available high throughput DNA extraction systems. NHSBT would like to improve our knowledge of all current and future systems available in the marketplace. This will aid identification of opportunities and gauge market interest in this field.

We require high throughput DNA extraction systems (s) to cover the following:

- The Solution must extract genomic DNA (from peripheral blood, buccal swabs, saliva,tissue) and cell free DNA (from plasma / serum).
- The Solution must be capable of running a minimum of 48 samples (ideally 96 samples)per batch.
